#### **BUSINESS LICENSE**

You may be required to purchase a state/county business license for Baldwin County.

Please see the enclosed Vendor Business License Check List enclosed.

If you have questions, please call the number listed on the Business License Check List. You may mail in your application with payment to the address listed on the Business License Check List, or you may go by any of the Baldwin County Probate offices located in Baldwin County to purchase your license.

Failure to obtain a state/county license may result in a citation issued with additional penalty, interest and fees.

Acceptable payment methods are listed at the bottom of Vendor Business License Check List.

### **SALES TAX**

See the reverse side of this letter for the TAX form to be completed to report your sales tax to Baldwin County. Your sales tax payment is due no later than the twentieth (20th) of the month following the event. Please attach your check or money order to the form and return in the enclosed envelope.

WHO FILES: <u>Everyone</u> registered for a booth or making tangibles sales during a festival event held within Baldwin County.

**No**te: If you had zero sales or did not attend, please complete the tax form noting your particular situation.

#### PLEASE NOTE:

If you have an individual sales tax account and will be combining these festival sales with your other sales, please list your Baldwin county Tax ID number on the tax form. Also, please include your Social Security or Federal ID number.

# ONLINE FILING INSTRUCTIONS FOR BALDWIN COUNTY TAXES

If you choose to file your Festival Sales Tax online through the My Alabama Taxes (MAT) electronic filing system, the following instructions must be followed to ensure proper posting of your tax return and remittance.

Vendors who do not have a Baldwin County Tax ID# must submit the online return/ payment indicating "One-Time Filing" and using the festival number 21885 in the City/County Tax Acc't# field in the Baldwin County column.

Click on the "One-Time Filing" wording and overwrite it with the festival number: 21885



Completed example for Baldwin County filing:

If you do have a Baldwin County Tax ID#, then you should include your festival sales when you file your taxes as normal. You will also need to complete and return the Festival Sales Tax Return provided in this packet, and correctly note that you will file the festival tax on your Baldwin County tax id#. (If you file and pay the festival taxes online, do not send payment with the Festival Sales Tax Return.)
